

## **Full Tilt Boots Boot Giveaway Rules & Regulations**

**OFFICIAL RULES TERMS & CONDITIONS Void where prohibited by law.**

**1. How to Enter.** NO PURCHASE NECESSARY TO ENTER OR WIN. To enter the Full Tilt Boot Monthly Giveaways (the "Giveaway") simply visit, <https://fulltiltboots.com>, enter your email, and submit.

You must complete all required information to be eligible to enter to win a prize. Incomplete, illegible, corrupted or untimely entries are void and will be disqualified. Entries must be submitted by the individual entrant. All entries become the property of Full Tilt Boots when submitted and will not be returned to entrant. Contest begins on September 1, 2018 and ends on September 1, 2019. Mail-in registrations must be postmarked by September 1, 2019.

All online reviews must be submitted by the end of each week. The drawings shall take place on or about **the first Monday of each month**. Winner shall be notified via Facebook and email within 5 days of the drawing. FULL TILT BOOTS' sole obligation is to send an email or post to the user information provided in the entry form. Winners will have 15 days from the sending date of the winner notification message or mailing of certified mail to acknowledge receipt of the winner notification. If the prize is not claimed within the 15 day time limit an alternate prize winner will be drawn at random from all eligible entries received.
